The passport must contain the signature or the fingerprint of the holder. At least 2 empty pages must be available in passport. Passport issued more than 10 years ago will not be accepted.	
3.	One recent passport photograph Note: (not older than 6 months); for men: without head cover. For photo specification please refer to our website https://www.vfsglobal.com/one-pager/hungary/uae/english/index.html	
4.	Letter from local sponsor Stating designation, salary and start date of employment in the UAE or Legally translated trade license if self-sponsored.	
5.	Leave Certificate from the Employer (NOC with leave details)	
6.	Hotel booking - full address of the host/the hotel must be written in the application: full name, street name, no. of building, city and city code.	
7.	Up-to-date personal bank account statement for the last 6 months - original and stamped from the bank. (dependents can produce the full documents of their sponsor)	
8.	Overseas Medical Insurance copy - covering the territory of the Member States of the Schengen Agreement and with minimum coverage of EUR 30,000 for medical expenses, repatriation and evacuation. Travel insurance should cover Covid-19 related events.	
9.	Flight ticket or flight reservation including return flight and 1 photocopy thereof.

- Applicants must appear in person
- All documentation must be submitted in English or Hungarian language
- For children registered in a parent's passport, a separate application form has to be submitted.
- Only original documents will be accepted; additional photocopies may be required
